Acknowledgement of the Risk and Waiver of Liability Relating to Communicable Diseases including Coronavirus/COVID 19 and Variants thereof

All Members Participating in Guild In-Person Events

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly (but not exclusively) from person-to-person contact. As a result, federal, provincial and local governments and health agencies recommend social distancing and wearing face masks.

Although the Ridge Meadows Quilters' Guild has put in place preventative measures aimed at reducing the spread of COVID-19, its variants, and other communicable diseases, RMQG cannot and does not guarantee that members will not become exposed or infected with COVID-19, its variants, and other communicable diseases.

By signing this Acknowledgement and Waiver, below, and in consideration of the undersigned member being permitted in RMQG in-person events, the undersigned member:

- **Acknowledges the contagious nature of COVID-19, its variants, and other communicable diseases, and that it is impossible for the RMQG to completely prevent exposure to COVID-19, its variants and other communicable diseases at in-person RMQG events;**
- **Voluntarily assumes the risk that the member may be exposed to or infected by COVID-19, its variants, and other communicable diseases at a RMQG event, including all risk of personal injury, illness, disability and/or death which may result from any such exposure;**
- **Releases and discharges the RMQG and anyone employed by or associated with the RMQG (members, guests at any event organized by the RMQG, or any family member of any of these) fully and completely from any claims, liability, damages, costs or expenses of any kind arising out of or related in any way to the undersigned member being exposed to or contracting COVID-19, its variants, and other communicable diseases whether or not that exposure or the member's contraction of COVID-19, its variants, and other communicable diseases results from or is contributed to in any way by any action, omission, or negligence of the RMQG or any person in any way affiliated with the RMQG: and**
- **Agrees not to commence or pursue any claim or legal proceeding in respect of any of the claims, liability, damages, costs or expenses which have been or are intended to be released by the preceding paragraph against the RMQG, anyone affiliated with the RMQG or any third party who may have a claim for contribution of indemnity against the RMQG or other persons affiliated with the Guild.**
